Poster submission:

- There are no fees to participate in this programme
- Posters sent by post will not be accepted. No exceptions will be made.
- Please ensure abstracts are submitted before 5pm on Friday , 20th February 2026
- No revisions can be made to the abstract following submission deadlines.

Preparing your poster submission:

Following review of your submitted abstract you will be notified by **13th March** as to whether or not your poster has been accepted. **Please do not submit your poster until you have received an acceptance email.**

All poster submissions will be available via a digital showcase at the PCCS 6th Spring Conference.

e-Poster Format:

- Your e-Poster should be formatted in a PDF as a landscape/horizontal slide that is 16:9 ratio, NOT 4:3. Presenting in 4:3 format may cause you distorted. (There is no file size limit)
- Place a heading that runs the full width of the e-Poster at the top in a large-sized type.
- The text should be no less than 8 mm (22 point font) and preferably larger.
- Use a constant font throughout the e-Poster.
- Use a black and bold type to ensure legibility and let your important points stand out.
- We suggest that you show the preferred sequence in which your e-Poster should be reviewed; this can be done by using 3 – 5 columns so the eye movement is down the columns.
- The figures tables should cover approximately 50% of the e-Poster area.

- Highlight your main findings. Don't hide your conclusions.
- We suggest that you structure your e-Poster by Introduction, Methods, Results, and Conclusions. State your aims in the end of the introduction.

Other recommendations and guidance:

- Please ensure that any abbreviations and acronyms are defined in the footnotes.
- Title of the document: Indicate the nature of the change management programme. The poster title and text may not contain trade names. The PCCS committee reserves the right to replace trade names in accepted posters.
- Methods: These should contain sufficient information to be able to understand the experimental design of the change management programme, the analytical techniques and the statistics used in the study
- Results: This should contain baseline data. A maximum of five total tables or figures may be submitted. Please be sure to number each table and figure and cite each table and figure in the poster text.
- Other items for consideration
 - In clinical studies, please state whether informed consent was obtained and whether the study was approved by a recognised medical ethics committee.
 - If the research included in your article was supported by a pharmaceutical or diagnostics company, you can indicate this when submitting your poster.
 - If off-label use of a drug was involved in the study, please state this clearly.

Poster Submissions

- Do not password-protect the file
- Please submit as a PDF files as described above
- No revisions can be made to the poster following submission deadlines.
- Authors will be notified if their poster has been chosen to be showcased at the 6th Spring Conference

A panel of experts will review the submitted summary abstracts and you will be notified of acceptance or non-acceptance by 13th March.
